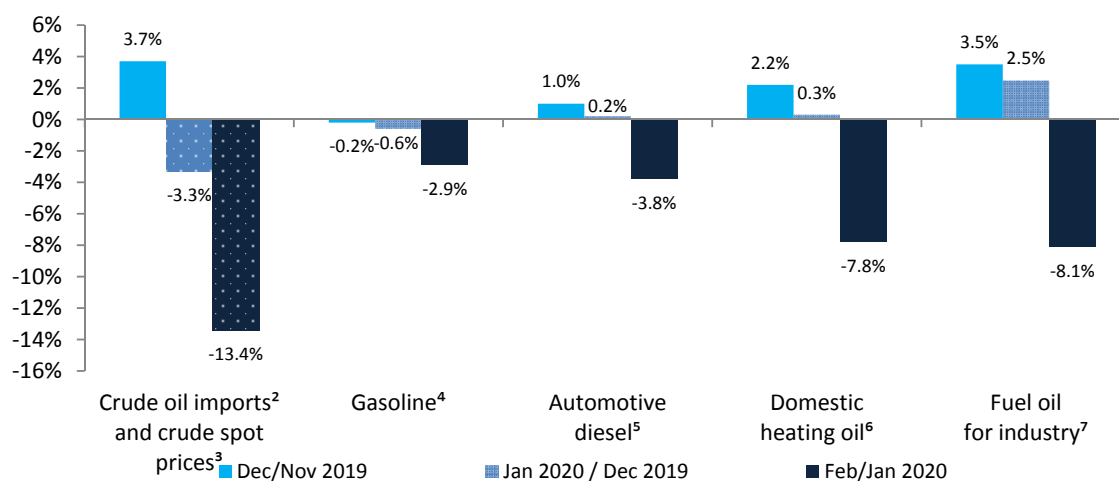

KEY TRENDS

- Spot prices fell by 3% in January and by 13% in February due to the demand decline influenced by the spread of Coronavirus Covid-19. As a consequence prices for all oil products decreased in each individual IEA country in February 2020.
- After small prices variations for transport fuels in December and January, prices strongly decreased in February: by 3% for gasoline and by 4% for diesel.
- Domestic heating oil and fuel oil for Industry fell by 8% influenced by the strong spot prices decrease. These products showed an higher correlation with the spot prices thanks to the lower influence of the taxation on the end-use price.

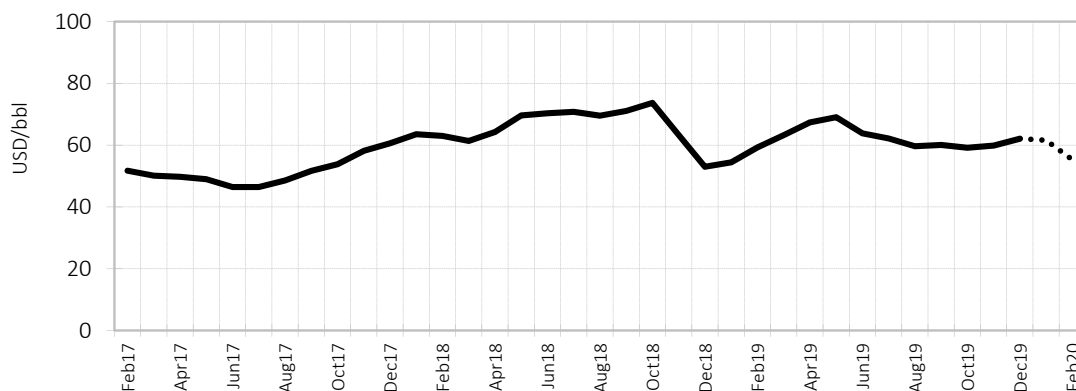
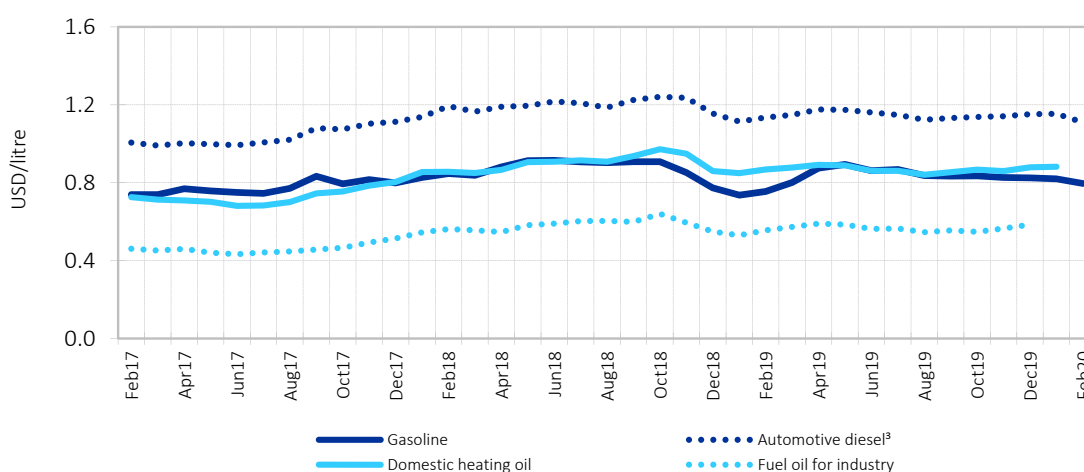
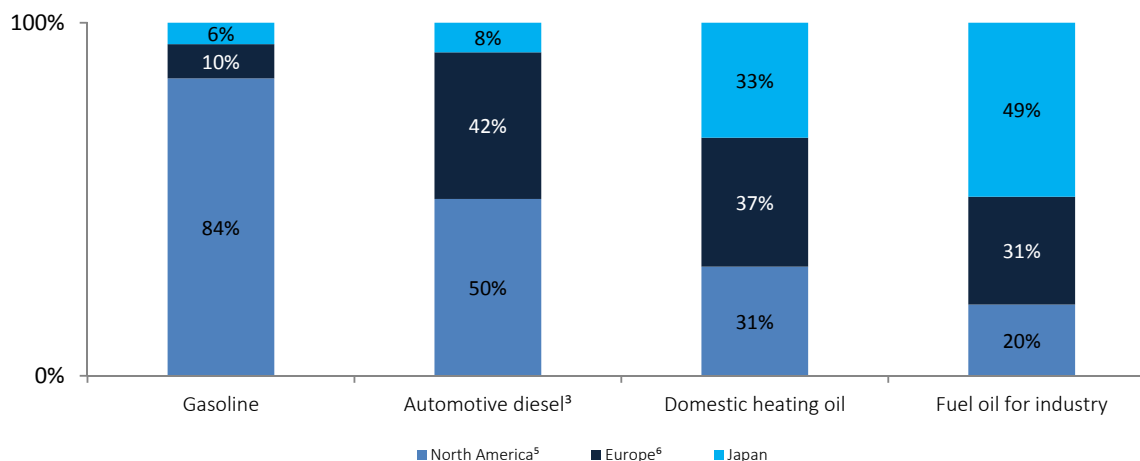

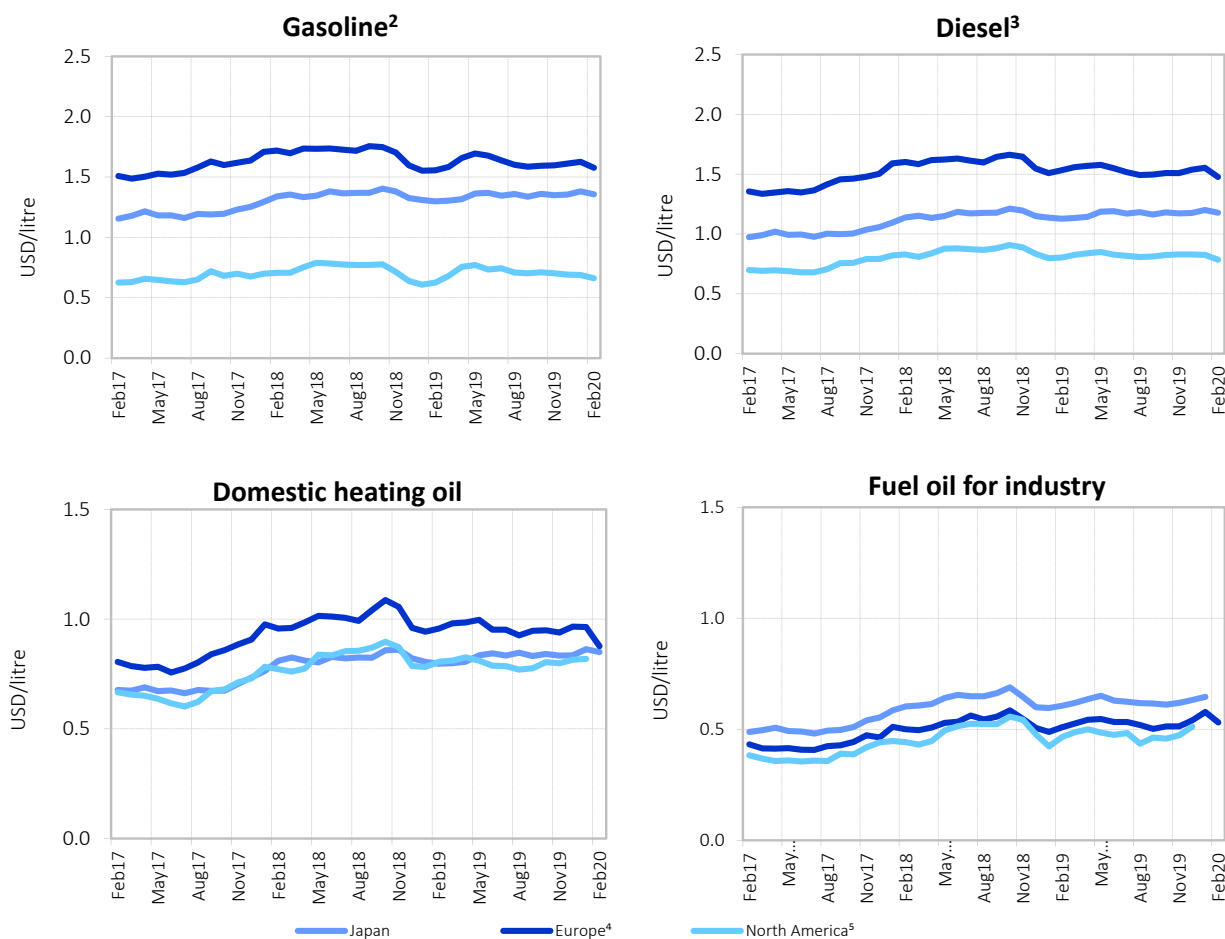
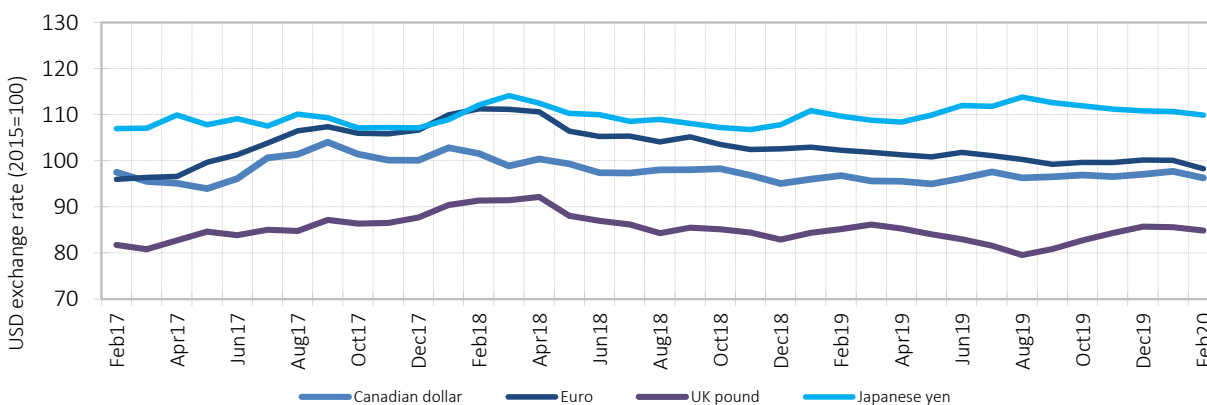
