1. Background

■ 1. Ukraine is Party of UNFCCC.

 2. Kyoto Protocol is ratified by Ukrainian Parliament on 4 February 2004.

2. Institutional Capacity Building Process

- Ministry of Environmental Protection of Ukraine is coordinator and responsible for development and implementation Climate Change Policy in Ukraine and implementation of UN FCCC and Kyoto Protocol according the Decree of the President of Ukraine on12 September 2005p № 1239 and is DNA
- The National Action Plan of the Implementation of Kyoto Protocol was approved by Government 18 August 2005 (Resolution №346-p).

2.1 Institutional Capacity Building Process

- JI Unit: Kyoto Protocol Supervise Division of the Ministry of Environmental Protection of Ukraine fulfils the function of the JI office
- National JI Policy: Policy is determined by requirements to the PIN and PDD contents that was registered in Ministry of Justice of Ukraine and as well State policy in field energy conservation

2.2 Institutional Capacity Building Process

- National registry: It is under installation now.

 Process ought to be finished to the end 2006 year
- National Inventory System: Formally was created by Government Decision "Procedure of the Functioning National System of the Estimation of Anthropogenic Emissions by Sources and Removals by Sinks of GHG not Controlled by the Montreal Protocol" (21.04. 06, №554)

2.3 Institutional Capacity Building Process

- Institutions which are involved in JI: Another Ministers across of the Inter-ministries Commission of the Climate Change, private or public entities as owner and (or) developer of JI projects.
- Ministry of the Industry Policy developed Guidelines for calculation GHG emission amount by the entity of mining and steal industry
- Ministry of Municipal Building developed Guidelines for calculation dangerous pollution from energy and heating supplying installations of municipal services.

3. Legislative Regulation

 Government of Ukraine adopted the Resolution "On Approval of the Procedure for Consideration, Approval and Implementation of Projects Aimed at Anthropogenic Emissions Reduction or Greenhouse Gas Absorption Increase Pursuant to Kioto Protocol to the United Nation Framework Convention on Climate Change" dated February 22, 2006 № 206

3. 1 Legislative Regulation

- It was issued two resolutions of the Ministry of Environment Protection of Ukraine (MEP) in which were determined the Requirements to the PIN and PDD contents and which where registered in Ministry of Justice of Ukraine 2 August 2006 (according procedure State Registration Procedure).
- PIN MEP: 17.07.06 № 341, Ministry of Justice: № 341 925/12799
- PDD MEP: 17.07.06 № 342, Ministry of Justice: № 342 926/12800

4. JI projects pipeline

- In 2004-2005 years there was submitted to Ministry of Environmental protection of Ukraine Project Idea Notes:
- 2004 17 JI projects.
- \blacksquare 2005 4 JI projects.
- 2006 22 JI projects

4. 1 JI projects pipeline

- In 20004 all project have got Letter of Endorsement (LoE) from Ministry. For most of them Project Design Documents were developed.
- In 2005 and half of the 2006 years the LoE for JI projects was not issued because it was arisen the discussion concerning of the internal procedure estimation of JI projects

4. 2 JI projects pipeline

- In 2006 7 JI project have got LoE and two Letter of Approval (LoA).
- Letter of Approval have got the projects:
- "Mine methane utilization at Coal Mine named after A.F. Zasyadko, Donetsk, Ukraine", submitted by the Coal Mine named after A.F. Zasyadko located in the city of Donetsk, Ukraine, dated 4.10.2004,
- "Heat and Power Production on Stripped Casing-head Gas at Boryslav" project, proposed by the Scientificproductive company "Eastern European Energetic Union" Ltd., located in the city Kyiv, Ukraine.

What is needed for facilitating JI activity?

- To develop guidelines and procedures for:
- baseline methods for deferent type JI projects;
- JI project monitoring and data report;
- additionality tests;
- uncertainties estimation in baseline;
- for methods for using conservative assumptions;
- GHG units transaction procedure
